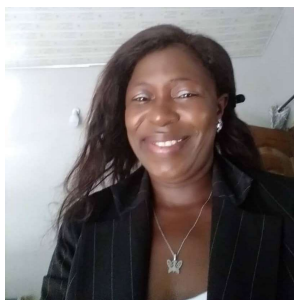
FUSEINA ADAMS (MRS.)
