

Workshop on Corporate Governance Communiqué

- ① *At a workshop organised by the State Enterprises Commission, with the Commonwealth Association for Corporate Governance and the Commonwealth Secretariat, held in Accra on 30th June, 2nd and 3rd July 1998, the participants recognised the need of good corporate governance as a basis for economic, social and environmental development, and therefore resolved to:*
- ② *Establish an institution that promotes Corporate Governance through which :*
 - (a) *information, training and education will be given to all stakeholders interested in corporate governance;*
 - (b) *a review on corporate governance in Ghana will be undertaken;*
 - (c) *a code of best practice for corporate governance can be endorsed by the stakeholders;*
 - (d) *roles and characteristics for company chairmen, chief executives, non-executive (external) directors and company secretaries will be defined; and*
 - (e) *a transparent and efficient system for appointing directors, who in turn will appoint Chief Executives, will be established.*
- ③ *In view of the above needs, a task force was constituted in the workshop made up of public-private sector representatives to pursue the establishment of the national institution in order to promote the above functions to reflect national priorities and international standards.*
